

Community Foundation

Distributions must be made only to charities which themselves offer tax deductibility for donations. Donations to this foundation are therefore tax deductible.

Extension Fund

Distributions from this Fund may be made for charitable projects and not necessarily to charities that offer tax deductibility. Donations to this Fund are therefore not tax deductible. This Fund is particularly suitable for bequests.

Early Beginnings

Rotary's early beginnings in Chicago in 1905 have grown to encompass a membership of 1.2 million Rotarians in 166 countries throughout the World.

The Rotary Club of Melbourne was the first Rotary Club in Australia. Since its inception in 1921, the Club has an outstanding record of philanthropic and charitable work, in many diverse areas of the community.

Some Past & Current Projects of the Rotary Club of Melbourne:

In local projects, some of these were

- In December 1921, taking 200 children from Queensberry Street State School to the beach at Carrum. This was the Club's first project and in most cases, the children's first car ride and sight of the beach.
- Raising thirteen thousand pounds in 1925 to establish a secretariat for the Boy Scouts and so enable its re-establishment after the loss of most of its leaders in World War 1.
- Significant involvement in the establishment and long term support of the apprenticeship system in Victoria.
- Various projects in conjunction with the Baker Medical Research Institute.
- Establishment of the Crossroads Youth Program with the Salvation Army.
- The establishment of Lifeline in conjunction with the Wesley Central Mission.
- Support provided to the Very Special Kids project.
- The establishment of the Donydji Homelands educational facility in Arnhem Land.
- The provision of the Soup Kitchen Van for disadvantaged people in the St Kilda area.

International projects have included

- The establishment of the Posyandu Public Health program in Indonesia.
- Various projects aimed at helping the re-establishment of life in Timor-Leste.
- Support given to the Cambodian Leprosy Eradication program.
- Support for the **Dental Health** project in Vietnam.
